

**PRINCE BANK PLC.
TERMS AND CONDITIONS FOR MOBILE APP SIGN UP AND REFERRAL
CAMPAIGN**

Prince Bank Plc. (“**Prince Bank**”) is launching the Prince Mobile App Sign Up & Referral Campaign in accordance with the terms and conditions herein contained (“**Campaign**”). By joining this Campaign and in addition to the applicability of the General Terms and Conditions (“**GTC**”), Terms and Conditions governing Digital Banking Services and other relevant terms and conditions, the customer agrees to be bound by the below terms and conditions:

1. All customers, including, individual existing and new customer, who has opened and maintained any saving and current account with Prince Bank (“**Customer**”) can join the Campaign by signing up on Prince Bank’s Mobile App and/or referring any Customer to sign up for the Prince Bank’s Mobile App.
2. The Customer who meets the following conditions will earn the points (“**Points**”) for redemption (“**Redemption**”) in accordance with this terms and conditions:
 - a. Successfully sign-up for the Prince Bank’s Mobile App for his/her own personal use; and/or
 - b. Successfully refer any new/existing Customer to sign-up for the Prince Bank’s Mobile App; and
3. The Reward will be provided as follows:

* 1 Point = 1 cent

4. The Customer understands and agrees that:
 - a. To meet the requirement of Redemption, the Points collected shall be accumulated within a specific period as determined by Prince Bank.
 - b. The Customer, at their choice, may redeem the Points collected to use for Mobile phone top-up, make Bill Payment, or Prince Pay in the amount equivalent to the Points collected (“**Services Subject to Points Redemption**”). Prince Bank has all rights to change the Services Subject to Points Redemption from time to time, at its sole discretion, provided that a notice is served on the Customer on Prince Bank’s official website or other applicable means of communication of Prince Bank.
 - c. The Customer shall regularly and diligently monitor the Points collected in Prince Bank Mobile App, by clicking the More Function and then in the PRINCE Rewards.
5. This Campaign shall be effectively from 01 April 2021 until 30 June 2021 (“**Campaign Period**”).
6. **Release from Liability, Disclaimer, and Limitation of Liability:**
 - a. The Customer irrevocably and unconditionally releases Prince Bank from all liabilities in case where the Points are redeemed by the unauthorized person.
 - b. Prince Bank disclaims any guarantee and liability, in any way whatsoever, on the availability of any reward (mobile phone top up, bill payment or Prince Pay),

redemption level, rebate or any other benefits associated with this Campaign as regards the addition or deletion of items from or for which the Points can be collected and/or redeemed.

- c. The Customer agrees that under no circumstances will Prince Bank, including Prince Bank's shareholders, directors, or employees, be liable for any damages whatsoever which includes but not limited to any direct, indirect, special or incidental damages arising out of or in connection with the Campaign.
 - d. The Customer hereby irrevocably agrees to indemnify and keep Prince Bank indemnified, at all times hereafter, from all losses, damages, costs, legal fees, charges and expenses and consequences whatsoever, suffered or incurred by Prince Bank on account of any claims, actions, suits or otherwise instituted by the Customer, or any third party whatsoever, arising out of or in connection with the provisions herein.

Prince Bank reserves all rights to make any amendment to the terms and conditions herein contained, to postpone, or to extent, or to cancel the Campaign, without bearing any liability, at any time during the Campaign Period, at its absolute discretion, provided that a proper notification on such change(s) will be duly posted on the official website or on other applicable means of communication of Prince Bank.
8. This terms and conditions shall be governed by the applicable laws of the Kingdom of Cambodia. Any dispute arising out of or in connection with this Campaign shall be resolved in accordance with the applicable consumer complaint handling policy of Prince Bank and shall be finally referred to the Cambodian competent court.
